Thomas J. Sargent specializes in the fields of macroeconomics, monetary economics and time series economics. As of 2011, he ranks 17th among the most cited economists in the world. Sargent, together with Christopher A. Sims, was awarded the Nobel Prize in Economics in 2011 “for their empirical research on cause and effect in the macroeconomy.” He also leads a reading group at Stanford University and New York University, which is highly noted as a famous institution among graduate students in economics.
